IMPORTANT CIRCULAR RELATED TO FEE

APRIL 21, 2020

Dear Parents,

Kindly be noted that the school has implemented the following changes in the fee structure (In the Online fee Portal) till the lockdown period as per the **Revised Directives issued by the DOE**, **GNCTD vide its order dtd 18/04/2020**.

- 1. Only tuition fee needs to be paid for the lockdown period. Please check the amount under the head **Tuition Fee** and make the payment. The online fee module has been activated accordingly, thus reflecting ONLY the tuition fee. This holds good for classes Preprimary to XII.
- 2. We would request the parents who preferred to pay through **cheque** earlier to pay the fees **ONLINE** via school's Online portal.
- 3. Parents who have already deposited the fees may note that fees paid under the heads other than tuition fee will be considered PAID and WILL NOT BE RE-CHARGED once the lockdown period ends. However, the parents who will pay the fees as reflected NOW shall be required to pay that amount later.
- 4. Arrears of monthly and annual charges will be payable after the opening of school as per your convenience.
