
Dear Parents,

You are aware that the Managing Committee of the School in its Meeting dated 25/11/2017 attended by parents' representatives and DOE Nominees had taken a unanimous and categorical decision to hike the school fee to a limited extent as permitted under the Order dated 17/10/2017 issued by DOE.

However, the said Order dated 17/10/2017 issued by the DOE came to be stayed in the proceedings held in WP() c) No. 11265/2017 titled "Ms. Taru Chauhan & Ors. V. GNCTD & Ors. Thereafter by way of an Order dated 01.02.2018, the aforesaid petition stands dismissed as withdrawn. Hence, the Order dated 17/10/2017 permitting a fee hike, stands revived and is thus in force.,

In pursuance to the decision taken in the Managing Committee Meeting dated 25/11/2017, you are hereby requested to clear the arrears of fee as per new fee structure already intimated. Parents are requested to deposit the amount before 31/03/2018.

We seek your utmost cooperation to implement DOE Order regarding implementation of 7th Pay Commission for employees of the school.

REVISED CIRCULAR

Dear Parents,

Directorate of Education, vide its order No. DE.15(318)/PSB/2016/19786 dated 17.10.2017 has directed to implement the recommendations of VII Pay Commission to the employees of Private unaided Recognized Schools of Delhi w.e.f. 01.01.2016. DOE has further directed to pay the increased salary of the employees from 1.1.2016 to 30.11.2017 as arrears and disburse the increased salary w.e.f. 1.12.2017 as per directives of DAVCMC, fee hike is being implemented w.e.f. 1.4.2017 so as not to burden the parents with fee hike for the period from 1.1.2016 to 31.3.2017. It may be relevant to mention here that the school has been allowed to raise fee only by 5% in 2 years. But in order to give quality education to students and also to disburse the salaries to the staff members as per VII Pay Commission, it has become essential to increase the Tuition Fee as per DOE guidelines. In this regard, the LMC meeting of the school was conducted on 25.11.2017 wherein the proposal for hike in fees was taken up. However, this hike in fees is not sufficient to meet the day to day expenditure of the school. We are however negotiating with DOE for more fee hike, but for the time being we are charging the increased Tuition fee @ 15%. To calculate the Arrears and increase in salary, DOE has issued procedure and guidelines so that the parents are least burdened. The detail of revised tuition fee with Arrears with 1.4.17 to 30.6.2017 and from 1.7.2017 to 31.03.2018 is as under:
